| (i) Required Expense Amount | 12,000,000.00 | Note 1: Under the terms of the Trust Indentures, Airplanes Group is required on each monthly payment date to maintain (as the "First Collection Account Top-up" in the priority of payments) a cash balance equal to the "Maintenance Reserve Amount". As at the September 16, 2013 payment date the Maintenance Reserve Amount for the purpose of the First Collection Account Top-up was \$110,000,000. As explained in Airplanes Group's press release published on October 8, 2013 (which is available on its website www.airplanes-group.com), as a result of the ongoing nature of the litigation between Airplanes Holdings Limited and Transbrasil and the absence of a concrete prospect of settlement or resolution, the board of directors of Airplanes Limited and controlling trustees of Airplanes U.S. Trust resolved on October 8, 2013 to increase the liquidity reserve held by way of the Maintenance Reserve Amount at the level of the First Collection Account Top-up in the priority of payments from \$110,000,000 to \$140,000,000 with immediate effect. Immediately prior to the October 15, 2013 payment date, Airplanes Group's cash reserves of \$110,000,000 previously retained at the First Collection Account Top-up thus fell short of the increased Maintenance Reserve Amount by \$30,000,000. Therefore, commencing on the October 15, 2013 payment date, Airplanes Group is retaining cash which would otherwise have been paid as class A minimum principal in order to increase the amount of cash held at the level of the First Collection Account Top-up and eliminate such shortfall and will continue to do so on future payment dates until the cash held at such level reaches \$140,000,000. The amount to be retained on the October 15, 2014 payment date which would otherwise have been paid as class A minimum principal is \$296,172.15. The class A minimum principal arrears have increased to \$429,479,858.65 as of the October 15, 2014 payment date. |
